This preacher is fed up. The rope is stretched taut and I am hanging by that proverbial single thread at the very end. My forbearance has expired. My gentle calmness has left. There churns within me what will not be quieted by chewing antacids, sipping a cup of warm tea, or soaking in a comfortable bath. This stirring is too deep for languid remedies. The 'madness' is not a Marvin M. Milquetoast fit of tepid anger to be cleared by stomping a foot or clearing the throat. Beyond the absence of tranquillity, a negative, I am boiling mad, also a negative—however, as I recall *two negatives make a positive*; so this will be one of the most positive articles that I have written. I have anger that requires verbal discharge (of both barrels of twelve gauge 00 buckshot) directed at the political and the intellectual and the psychological and, especially, the spiritual leadership of this nation. From their mouths come irrationality such as should institutionalize them for the safety of others. They confess that the nation is in a mess, but cannot recognize the cause of the trouble; and, therefore, have no concept of how to fix the problem. Bluntly stated, they are the problem. This land is cursed because America has followed their erroneous political, intellectual, psychological and spiritual beliefs and practices.

This is written in the aftermath of the slaughter in the high school in Colorado. The events of these last few days compel me to address them; they cannot be ignored. The mid-day mayhem committed in classrooms and hallways of an academic institution is neither the source nor subject of my anger. Certainly, the actions of the two twisted souls involved produce anger: anger mixed with loathing; however that anger is nothing as compared with that which seethes within my soul as I write. This is anger joined with righteousness. I cannot maintain silence concerning the response of the 'professionals' and the pundits to the actual barbaric act.

One repeatedly hears statements expressing the same sentiments from every field of expertise existing in America so uniform in utterance as to make one consider the 'possibility' of a conspiracy. How can so many who are so qualified be so stupid at the same time? The only answer is that they all believe the same foolishness.

*What is wrong with America? How*

*could this happen in one of the nation's top schools? How can children kill children? What new laws are needed to solve this problem with our kids? I am announcing (or calling for) 'such and such' program to deal with the crisis of guns in the hands of children. You cannot blame films and television. Why did the authorities not stop them from dressing in black, wearing trench coats, and calling themselves a Mafia?*

While not expressing all that I have heard since this savagery occurred, these inanities are sufficient to enable my reader to relate to my comments. What results has this overthrow of restraint provided? In a land where students once made spitballs and were paddled and suspended, students now make pipe bombs. In a land where a water pistol in a back pocket would bring swift, applied judgment to the seat of learning, rifle fire is heard in the cafeteria. Running in the halls obtained a trip to the principal's office in my day, now it becomes a matter of life and death. No one can deny that America is a land being cursed. What makes me so very angry is that those who crusaded to bring the causes now wonder how the curse came. I am constrained to tell them so.

from controlling what is in the backpacks and lockers of students. I wonder what was found in the backpacks and lockers of that school. Could any of it be used to discipline or to prosecute some student for possession of obscene materials, drugs, or drug paraphernalia? Imagine the uproar that would produce? Invasion of privacy, unlawful search and seizure—and numerous other challenges would immediately be funded by special interest groups.

As to restricting the use of a particular word, the school board would be sued over any attempt to do so (unless it is 'Jesus') and the teachers and administrators know it. The ACLU would have been first in line to hang any teacher that dared to douse a flag on fire. One or both of these boys made a video as a class project showing themselves killing students in the hallways of the school—according to CNN. A teacher is grieving because one of the boys wrote a paper on 'dreams' about the same thing—according to the PIO of that local sheriff. As for the fascination with Hitler, if the schools really taught real history, there would be little attraction to Hitler. Yet, I recall the ACLU defending the Nazi march in Illinois. Would that group have allowed the school to expel a student for a fascination with Hitler? Student newspapers across the nation have printed offensive material and the courts have upheld the right to do so and have prevented schools from (the dreaded word) censorship—the same courts that have censored God and righteousness out of the same schools. It is not amazing that we face a curse. It did not arrive by accident. What upsets me is that the very people who are asking this kind of question caused the problem.

*How could this happen in one of the nation's top schools?*

We are told, by commentators with straight, concerned faces, "This was not an inner city school." What nonsense to connect violence to the inner city and peace with the affluent suburbs. No one knowing human nature expects crime and violence to be restricted only to an inner city. It takes a liberal who believes that environment has the power to produce either goodness or badness to espouse such drivle. Such have never seen a rose bush grow alongside a pig lot. Send them to a farm for summer CEU's in-

stead of ivied halls of academia. When the (national) experts are (biblical) fools, it is not a matter of wonder that we face a curse.

Personally, I was not impressed that the students, as shown via the media, were high achievers. During interviews, the majority of the students did not

present an image of having received strong tutelage. The grammar used was poor; the reasoning was poor; the vocabulary was poor; the choice of attire was poor. Exceptions were noted; but overall the students would not have passed Pearl Bartley's English class in 1958. In the guise of making poor schools good and good schools better, the Federal government, during the Eisenhower administration, over the objections of good men, created a Department of Education. Uncle Sam has made quite a mess out of a public education system that was once the envy of the world. America led the world in literacy when Uncle took over and now we are well down the list. For anyone interested in a remedy for the schools, I offer a simple one. Return the discipline of the 1940's and the 1950's to the schools; re-institute corporal punishment in the elementary schools; re-empower the parents to control their children and the schools; revive the moral absolutes of right and wrong; remove those who disrupt. In short, return all that the experts removed.

preme Court and as funded by the Congress of the United States and as encouraged by the President. In fact, children are assured they have the right to do so. Children are told, directly and indirectly, that they need not feel any remorse or guilt for killing another human. Children are taught that children are disposable options. When a nation values human life so low, it is no wonder that the children of the nation feel the freedom to do the same.

In a land where O J cannot be found guilty, where sons slaughter their parents (pausing to reload) and have a juror bemoan the fact of their being orphans and refuse to vote guilty, where it has taken some forty deaths to stop Jack Kevorkian, where character does not matter—what should we expect from children? By the way, has everybody forgotten Waco and Ruby Ridge? The government had no apprehension and suffered no consequences over burning children or shooting a mother holding a baby. A new program to prevent that kind of crisis would be welcomed.

*What new laws will solve this problem with our kids?*

Those two had previously been adjudicated law-breakers, did community service, were, thereby, rehabilitated (less than 90 days ago) and received letters of praise allegedly with a written expectation that

they had the potential of becoming community leaders. They tested the system and found that the law was a toothless hound. More laws would not have prevented the massacre; but better enforcement of laws previously broken by the boys might have. As it is, there are all kinds of laws against what these boys did. Local laws, state laws, and federal laws all touch upon some aspect of their assault on the school. Murder is against laws everywhere—except in Jack Kevorkian's mind, within abortion clinics and before certain California juries. Guns are federally forbidden within a specified distance of any school; however, that did not prevent the deed. By the way, that school district has a rule against cell phones— obviously, it was widely violated. Only those who broke that rule are praised. What would have been the result if a teacher or student had broken the law by carrying a handgun and had shot both boys dead as they began the rampage? The media will not discuss that concept; and I do not recommend it; but, it is interesting to speculate on the reaction.

Laws or the absence of laws is neither cause nor effect of the curse on America. There is a spiritual vacuum in the children of America, because the adults and the parents of America have rejected the God of the Bible and made themselves gods after their own desires. We are seeing today the results of thirty years of raising children in a country where values fluctuate, morals are debatable, standards are ne-

to the masses—"a Judaic-Christian nation."

After all, as we are often reminded, the Supreme Court of the United States once upon a time (sounds like a fairy tale) ruled (in one decision) that "The United States is a Christian nation." So what, the Supreme Court once also ruled that Dred Scott was a non-person because he was a slave; that babies in the womb are a mere appendage of the body and may be discarded as a woman would a ruptured appendix or a cancerous tumor; that "the well being of the land" (A.K.A. "public policy") takes precedence over time honored, strongly held, sincerely believed, fervently practiced, Bible based religious beliefs; that prayer in public is

an affront to the conscience of the non-believer while profanity is a constitutionally protected free speech right, that burning the American Flag is protected free speech—need I continue to cite the bad judgment exercised by the Supreme Court?

While we often have been fortunate, as a nation, to have decent, honest judges sit on that high bench, we have also been most unfortunate to have some who apparently were neither and some who never seem to have even bothered to read the Constitution a single time! I have no fear in predicting that The Supreme Court of the United States (which opens every session with "God save the court") will be found often reversed and frequently overruled at the final review before

gotiable, truth is flexible, and where sin is deemed an alternative. We can expect to be cursed.

Where might these boys have learned how to terrorize a school and to blow up buildings? I dare say from the war protesters and the black radicals of the 1960's. People currently in power seem to forget that buildings were being blown up back then. Shoot-outs, even in courtrooms, were not rare. Speakers at colleges encouraged students to 'off their parents' and to 'kill the pigs.' Children today are only following in distinguished, high profile footsteps. Our national life is led by some who led the way. Check offices in Washington and positions in Hollywood for confirmation.

The problem is not what is in the hands of the children, but with what is in their hearts. Using such calamities for political profit is sick politics practiced by sick, not slick, politicians. I cannot respect that effort. It may garner votes, but that process is the source of most of the bad laws and bad

government that we have today. Look how the civil rights act—intended, in theory, to right a serious wrong—has been used to foster perversions. Laws made to fix a crisis are laws that are emotion and not rational.

Will we be able keep plastic pipe and propane tanks from children with a law? No good parent would knowingly allow a child to play with propane tanks, make pipe bombs, trifle with weapons or plan murders and no law will prevent any child of the other kind of parent from doing so. Parents do need to re-assume responsibility for their children and that involves not always going behind them to see that they pay no penalty for their wrongs. Wrong behavior of children too often receives no penalty in our soci-

ety and sets the stage for greater wrong. Yet, it would be a mistake to place the blame for such actions as this carnage solely on parents; remember that David's children numbered a rapist and murderers among them. the Great White Throne by the living and true Supreme Judge of the Universe! Even so, setting my views aside, why on earth would any one choose to quote the Supreme Court as the authority on whether or not America is a Christian nation?

I quickly and gladly concede that when the Pilgrims landed at Plymouth Rock, they (the Pilgrims) were predominately Christian in personal faith, moral conscience and private (and public) practice--there is even some evidence to indicate that several were actually Baptists in affiliation. *The Mayflower Compact* is a marvelous piece of historical record to

read and certainly expressed sincere Christian desires and intentions.

Yet in the passage of time, religious persecution (*NOT BY THE PILGRIMS* but) by "the established church" in Massachusetts and Virginia and Maryland and elsewhere was common. By the time (a century and a half later--four or so generations from the Pilgrims) "the founding fathers" wrote The Declaration of Independence (largely the verbiage, as all authorities affirm, of Thomas Jefferson--a man who took his scissors and removed all supernatural events or teachings from the New Testament to produce the real "Jesus" [which act he boldly declared to be as easy as distinguishing "diamonds in a dung-hill"]--*The Jefferson Bible* is available through any book

distributor as ISBN 0-8050-3853-1) and the Constitution, they were not predominately Christian in personal faith, moral conscience or private (and public) practice. They were, at this point of our history, merely "greatly influenced in their thinking by the Bible, moral values, and their church (sic)."<sup>1</sup> These founders (*Jefferson was not one of the framers of the Constitution as he was in France*), except for three<sup>2</sup> were identified "orthodox members of one of the established Christian communions: approximately twenty-nine Anglicans, sixteen to eighteen Calvinists, two Methodists, two Lutherans, two Roman Catholics, one lapsed Quaker and sometime-Anglican, and one open

Deist--Dr. Franklin who attended every kind of Christian worship, called for public prayer, and contributed to all denominations."<sup>3</sup>

These may have been, undoubtedly were, good men, perhaps the greatest that this nation has ever produced, and they certainly assembled an amazing document, properly ranked among the noblest ever written by mere men--BUT THEY WERE NOT INSPIRED BY GOD and the Constitution is not a Covenant made by or with God.

It is not my purpose to defame any of the founders and in such a short article I could not give biographical sketches of each of the 55 delegates (sixteen of whom did not sign the document and some who did, did so with reluctance). It is also a historical fact, though

no current history text used in the public schools would dare to reveal it, that Patrick Henry, elected as delegate from Virginia, so strongly opposed the concept of a Federal Constitution because it would place too much power beyond the state level that he refused to attend any sessions! Nor will it be taught that, finding the Constitution ratified, he led the fight to force the States to adopt the Bill Of Rights--all of which were left out of the original Constitution! Henry, perhaps the greatest orator and statesmen of his age (I think in American History!) was adamant for the Declaration ("I know not what course others may take....but give me liberty or give me death!") but he feared and warned against the potential excesses coming from a central government. Leave reading the Federalist Papers for awhile and take the time for a diligent reading of the Anti-Federalist Papers! (Yes, those are book titles and both are in print.) You just might find that Henry and others were right about some serious dangers/deficiencies of the Constitution.

I hasten to the point of this article "Can I, that is, do I have the ability by virtue of God-given authority to ask The Lord God Almighty to bless America? The word "bless" is interesting in its derivation as it comes to us from the Anglo Saxon word (*bledsian* derived from *blod*) for blood and has the connotation of blood being used as a means of consecration. (Merriam Webster's Collegiate Dictionary, Tenth Edition, gives the meaning of bless as: to hallow or consecrate by religious rite or word, to invoke divine care for, to approve, to confer prosperity or happiness upon--and then gives as the archaic use, which term, by the way, will prove most often to identify the use of the King James translators--to protect or to preserve). Therefore, the question is "Do I have the authority from

*Jehovah, the Lord God of Hosts, to ask that He would give America happiness and prosperity through His protection and preservation? Can I ask God Almighty to bless this land--to consecrate America through a covenant of blood?*

Certainly, I MAY say the words asking for God to bless America, but CAN I pray them with a sincere expectation for God to do so? The question is not of the form that the sentence takes but the sincerity of the expectation. On what scriptural basis could I anticipate that God would or should bless America?

IN THE FIRST PLACE, is there an indication of any desire on the part of America (as a nation) to receive the blessing of God?
